Wiltipoll Transfer Form

Use this form to:

- Record the details of registered and unregistered sheep being sold; and
- Provide the purchaser with a declaration that the sale sheep are either registered or unregistered

Please send completed forms to the membership services office as soon as possible or within 60 days of sale.

When the membership services office receives your form, it will:

- Verify eligibility of registration (for registered animals)
- Process a transfer and provide a certificate of transfer to the purchaser with a copy to you
- If the purchaser is not a current member or recent purchaser, a membership application form, and association newsletter will be sent with the certificate of transfer with additional information about joining the association

Request to transfer previously unregistered animals as registered animals

If the animals included in your transfer request are eligible for registration but have not yet been registered, please complete the breeding information in the table below. The situation where an animal has not previously been registered commonly occurs if you are selling lambs before you have had the opportunity to record them on your annual flock return. Please attach further details to this form if the animals have not been previously registered for any other reason (late fees for lapsed registration may apply) or if there is insufficient room for all of your information.
